
I Richard Kochanny being duly sworn under oath, does depose and declare as follows:



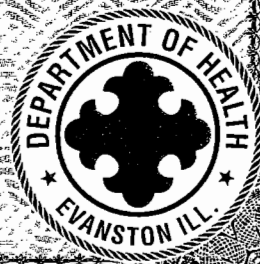
